# TERMS AND CONDITIONS FOR THE 6th NORTH MACROREGION HELPS CHARITY RUN - virtual and in-person run

## I. GENERAL INFORMATION

- 1. This document sets out the terms & conditions for the organization of the 6th NORTH MACROREGION HELPS Charity Run virtual and in-person run (the "Run").
- 2. Objectives of the Run:
- a) **to raise funds for Centrum Opieki Wytchnieniowej** [COW, a respite care centre for families taking care of chronically ill persons] run by the Hospice Foundation in Gdańsk (business registration number: KRS 0000201002);
- b) to promote a healthy and active lifestyle, while ensuring safety in accordance with the applicable sanitary regime during the Run;
- c) to bring together local communities and businesses.

# 3. The Run is organised by:

Jana Pawła II 17, 00-854 Warszawa, registered by the District Court for the capital city of Warsaw, 12th Commercial Division of the National Court Register, under KRS no. 0000120807, NIP 897-16-35-900, represented by Marzena Atkielska, President of the Management Board,

(the "Organiser").

## II. DATE, PLACE AND FORMAT OF THE CHARITY RUN

# 1. Virtual run

- a) The virtual run will take place on **23 September 2023** (Saturday), between **6.00 a.m.** and **10 p.m.** CEST.
- b) Given the virtual format of the run, the participants can join it from **anywhere in the world.**
- c) Distance: 7.4 km
- d) The number of the virtual run's participants is not limited.

## 2. In-person run

- a) The run will take place on **23 September 2023** (Saturday), between **11.00 a.m.** and **1 p.m.** CEST.
- b) The in-person run will take place in **Gdańsk**; schedule:
  - Collect your Event Pack from 8a.m. to 10:30a.m. at Santander Work Cafe in Gdańsk, address: Aleja Grunwaldzka 472
  - START TIME: 11:00 a.m. Work Cafe Santander Gdańsk, Grunwaldzka 472 two groups:
    - ✓ Group 1 RUN up to 60 minutes max
    - ✓ Group 2 WALK-RUN from 60 to 120 minutes
  - FINISH LINE: get there by 1p.m. Plac Zebrań Ludowych in Gdańsk, Brama Oliwska
- c) Distance: 7.4 km
- d) Pariticpant limit: max. 1000 people
- e) Route: Gdańsk Aleja Grunwaldzka, Aleja Zwycięstwa, 3 Maja Giełguda
- 3. The registration office is located at the headquarters location of the Northern Macroregion: Gdańsk, Al. Grunwaldzka 472.
- 4. To ensure runners' safety, on 23 September 2023 (Saturday) the **RIGHT LANE** of the following roads: Aleja Grunwaldzka, Aleja Zwycięstwa, 3 Maja Giełguda in Gdańsk, will be closed from **10a.m** to **2p.m**.

#### III. RULES

- 1. The event is not a mass start.
- 2. The run will take place both virtually and in-person.
- 3. Given the charity nature of the event, the Organiser will not measure finishing times and will not rank the participants.
- 4. The distance is **7.4km running or walking**. **Virtual runners** can use rollerblades, go by bicycle, by scooter or otherwise.
- 5. Each runner has to have the **run registration number**.
- 6. Once the virtual or the in-person run is completed, the participant reports it to the Organiser:

in the form of a **photo of the participant and/or a print screen showing the distance run** (please choose a hashtag as provided for in section 9).

- 7. The participants will get an **electronic certificate** of the 6th edition of the charity run. It can be downloaded via: <a href="https://elektronicznezapisy.pl">https://elektronicznezapisy.pl</a> starting from the 24th of September 2023.
- 8. **In-person runners** will get a medal.
- 9. Hashtags for the run to be used in social media: Facebook, Instagram and others: #PodarujWytchnienie, #PółnocnyPomaga, #FundacjaSantander, #SantanderBankPolska, #SantanderTFI, #FundacjaHospicyjna, #TumboTeam, #COW.

10. Given the charity nature of the event, the Organiser does not offer any prizes.

#### IV. PARTICIPATION CONDITIONS

- 1. The event is open to **people aged >18 as well as to minors (who must be supervised by adults)**. The participants must register for the event and pay an entry fee.
- 2. The participants can **REGISTER** for the run **from 1 September 2021 to 20 September 2023 by 23:59:00 p.m.** CEST, using the **registration form** at: <a href="https://elektronicznezapisy.pl">https://elektronicznezapisy.pl</a>.
- 3. The **list of participants** will be published on the **registration site** at <a href="https://elektronicznezapisy.pl">https://elektronicznezapisy.pl</a> (only participants who registered and paid the fee will be included).
- 4. The **race numbers in the PDF format** will be issued in the order of payments, after transfer confirmation. They can be downloaded at <a href="https://elektronicznezapisy.pl">https://elektronicznezapisy.pl</a> staring from 21.09.2023.

#### V. ENTRY FEE AND DONATIONS

## 1. The entry fee is

- a) **PLN 30** or more (at your discretion) for adult runners;
- b) no entry fee is paid by **children and teenagers up to 18 years** old;
- c) the fees should be paid to the account of Santander Bank Polska Foundation using the link each participant will get to their e-mail address once they have registered for the run at <a href="https://elektronicznezapisy.pl">https://elektronicznezapisy.pl</a>
- 2. **Donate money!** Anyone who cannot participate in the Run but wants to support **the respite centre in Gdańsk** can make donations to the account of Santander Bank Polska Foundation:

- 3. The first **10 persons** who donate PLN 1,000 or more (the date when the transaction reaches the account will be considered) will receive a special **Amber Heart** statuette (details are provided in Appendix 2 to these Terms and Conditions).
- 4. The funds for the respite centre will be raised by Santander Foundation from **1 to 30 September 2023**.
- 5. **The total amount raised** (fees, donations) will be spent to provide equipment and open the respite care centre in Gdańsk by 31 October 2023. In addition, Santander Bank Polska Foundation will donate PLN 10,000,00 to support the construction of the respite care centre.
- 6. The entry fees and other donations made as part of the fundraiser for the respite care centre in Gdańsk <u>are non-refundable</u>.

Each participant (or the participant's parent or legal guardian) represents that their health conditions enable them to take part in the 6th Charity Run (the statement to be made by the participant is attached as Appendix 3 and the statement to be made by a participant's parent or legal guardian is provided in Appendix 4).
- 2. The Organiser <u>does not provide</u> the participant with life insurance, health insurance and/or civil liability insurance with respect to any health problems that may result from the participation in the event and <u>holds no related liability</u>.
- 3. The Organiser and its partners as well as persons engaged in the organisation of the run are not liable to the participants for any accidents, collisions, personal injuries or physical or property damage occurring before, during or after the run and caused by the participants or third parties. The participants are subject to civil and legal liability for any damages made.
- 4. The participants are obligated to adhere to the safety measures and are fully liable for their conduct.
- 5. The Organizer will provide medical services only to runners along the route from the start time to the finish time (set at a specific hour). The Organizer will not cover any medical costs or transport costs that are not covered by the run insurance policy.
- 6. The participants acknowledge that the run is associated with physical fatigue, risk of accidents, potential bodily injuries or harm (including death), property damage or financial losses.
- 7. The participants undertake to comply with these Terms and Conditions. By signing the registration form, the participants will acknowledge that they have read these Terms and Conditions and accepted them.
- 8. A failure to read these Terms & Conditions does not mean that a participant does not have to adhere to them.
- 9. The participants are obligated to follow any instructions from the police or municipal police officers and the Organizer's emergency services and stewards responsible for the Run's safety on and around the route.
