

**RULES FOR  
THE 7th SANTANDER POMAGA CHARITY RUN - virtual and in-person run**

**I. GENERAL PROVISIONS**

1. This document sets out the terms & conditions for the organization of the **7th SANTANDER CHARITY RUN - virtual and in-person run** (the "Run").

2. Objectives of the Run:

(a) **collection of money** for the Santander Bank Polska Foundation "We Multiply Good," which will start on September 2 and last until September 27. The initiative is partnered by:

- **Hospicjum ks. Eugeniusza Dutkiewicza SAC w Gdańsku (Rev. Eugeniusz Dutkiewicz Hospice SAC for Children in Gdańsk)**  
**ul. Kopernika 6, 80-208 Gdańsk,**
- **Ponadregionalne Centrum Onkologii Dziecięcej, "Przyłodek Nadziei" (Supra-regional Children's Oncology Center "Przyłodek Nadziei")**  
**ul. Borowska 213, 50-556 Wrocław**

b) to promote a healthy and active lifestyle, while ensuring safety in accordance with the applicable sanitary regime during the Run;

c) to bring together local communities and businesses.

3. The Run is organised by:

(the "Organiser").

## II. DATE, PLACE AND FORMAT OF THE CHARITY RUN

### 1. Virtual run

- a) The virtual run will take place on **21 September 2024** (Saturday), between **6.00 a.m.** and **10 p.m.** CEST.
- b) Given the virtual format of the run, the participants can join it from **anywhere in the world.**
- c) **Distance: 7.4 km**
- d) The number of the virtual run's participants **is not limited.**

### 2. In-person run

#### **GDAŃSK:**

- a) The run will take place on **21 September 2024** (Saturday), between **11.00 a.m.** and **1 p.m.** CEST.
- b) The in-person run will take place in **Gdańsk**; schedule:
  - Collect your Event Pack from 8a.m. to 10:30 a.m. at Santander Work Cafe in Gdańsk, address: Aleja Grunwaldzka 472
  - START TIME: 11:00 a.m. Work Cafe Santander Gdańsk, Grunwaldzka 472 - two groups:
    - ✓ Group 1 - RUN with time measurement
    - ✓ Group 2 - WALK-RUN from 60 to 120 minutes
  - FINISH LINE: get there by 1p.m. Plac Zebrań Ludowych in Gdańsk, Brama Oliwska
- c) **Distance: 7.4 km**
- d) **Participant limit: max. 1000 people**
- e) **Route:** Gdańsk Aleja Grunwaldzka, Aleja Zwycięstwa, 3 Maja Giełguda, a map of the run will be available at [www.fundacja.santander.pl](http://www.fundacja.santander.pl)

#### **WROCŁAW**

- a) The run will take place on **21 September 2024** (Saturday), between **11.00 a.m.** and **1 p.m.** CEST.
- b) The in-person run will take place in **Wrocław**; schedule:
  - Collect your Event Pack from 8a.m. to 10:30 a.m. in Grabiszynski Park in the tramway loop terminal in Oporów in Wrocław
  - START at 11 a.m. in Grabiszynski Park in the tramway loop terminal in Oporów in Wrocław, in two categories:
    - ✓ Group 1 - RUN with time measurement
    - ✓ Group 2 - WALK-RUN from 60 to 120 minutes
  - FINISH at 1 p.m. in Grabiszynski Park in the tramway loop terminal in Oporów in Wrocław.
- c) **Distance: 7.4 km**
- d) **Participant limit: max. 1000 people**

e) **Route:** It will be set in Grabiszynski Park - the map of the run will be available at [www.fundacja.santander.pl](http://www.fundacja.santander.pl)

3. The run offices are located in:

**Gdańsk** - headquarters of Santander Bank Polska Macroregion North Gdańsk, Al. Grunwaldzka 472

**Wrocław** – in Grabiszynski Park in the tramway loop terminal in Oporów

4. To ensure runners' safety on 21.09.202 (Saturday) from **10 a.m. to 2 p.m.:**

- **in Gdańsk** - there will be a temporary change in traffic organisation in the following streets: Aleja Grunwaldzka, Aleja Zwycięstwa, 3 Maja, Giełguda; **THE RIGHT LANE** will be closed.

- **in Wrocław** (Park Grabiszyński) the route will be set and secured by the organizer. The run will take place in the park area.

### III. RULES OF THE EVENT

1. The run will take place virtually and in-person format, in locations in Gdansk and Wrocław.
2. The organizer shall carry out time measurement for participants who wish to do so. When registering for the run, the participant self-declares their desire for timing. Time measurement is only possible for participants over 18 years old.
3. The distance is **7.4km running or walking**. **Virtual runners** can use rollerblades, go by bicycle, by scooter or otherwise.
4. Each runner starts the **run with registration number, assigned by [www.elektronicznezapisy.pl](http://www.elektronicznezapisy.pl)**
5. **Once the virtual or the in-person run is completed**, the participant reports it to the Organizer:
  - a) by making a comment to a pinned post **on the Facebook profile of Santander Foundation** <https://www.facebook.com/FundacjaSantander>
  - b) and/or at **THE 7th SANTANDER POMAGA CHARITY RUN** <https://www.facebook.com/events/461350580056257/?rdid=owYan8juifjmQVY>
  - c) and/or **e-mail address:** [Santander.pomaga@santander.pl](mailto:Santander.pomaga@santander.pl)in the form of a **photo of the participant and/or a print screen showing the distance run** (please choose a hashtag as provided for in section 9).
6. The participants will get an **electronic certificate** of the 7th edition of the charity run. It can be downloaded via: <https://elektronicznezapisy.pl> starting from **the 25th of September 2024**.
7. **In-person runners** will get a medal.
8. Hashtags for the run to be used in social media: Facebook, Instagram and others: #FundacjaSantander, #SantanderBankPolska, #SantanderTFI, #SantanderLeasing, #SantanderFactor, #onkologiadzecieca,
9. Given the charity nature of the event, the Organizer does not offer any prizes.
10. The Organizer provides access to deposit boxes in Wrocław and Gdańsk.

### IV. PARTICIPATION CONDITIONS

1. The event is open to **people aged >18 as well as to minors** (with the consent of the parents or legal guardians). The participants must register for the event and pay an entry fee. The entry fee does not apply to participants below 18 years of age.
2. The participants can **register** for the run **from 21 August until 16 September 2024 by 23:59:00 p.m. CEST**, using the **registration form** at: <https://elektronicznezapisy.pl>.
3. The **list of participants** will be published on the **registration site** at <https://elektronicznezapisy.pl> (only participants who registered and paid the fee will be included)
4. The **registration numbers in the PDF format** will be issued after transfer confirmation. They can be downloaded at <https://elektronicznezapisy.pl> **staring from 18 till 21 September 2024**.

**Run participants in Gdańsk and Wrocław may collect their REGISTRATION NUMBERS on the day of the run on 21 September 2024 from 8.00 a.m. Participants are required to have a valid photo ID for verification and to collect the event package.**

## **V. ENTRY FEE AND DONATIONS**

1. **The entry fee for 7th SANTANDER POMAGA CHARITY RUN**
  - a) **PLN 30** or more (at your discretion) for adult runners;
  - b) no entry fee is paid by **children and teenagers up to 18 years old**.
  - c) The **fees should be paid** to the account of Santander Bank Polska Foundation using the link each participant will get to their e-mail address once they have registered for the run at <https://elektronicznezapisy.pl>
2. **Donation** - anyone that cannot participate in the Run but wants to support the We Multiply Good initiative for children's oncology can donate to the fundraiser run by Santander Foundation:

3. The fundraiser will support the charity initiative run by the Foundations and the Bank for children's oncology. The initiative will be run from 2 till 27 September, terms and conditions and apply.
4. **The total amount raised** (fees, donations) as part of the **7th SANTANDER POMAGA CHARITY RUN** will be spent to support the charity.
5. The entry fees and other donations made as part of the fundraiser in both locations are non-refundable.

## VII. FINAL PROVISIONS

1. Each participant (or the participant's parent or legal guardian) **represents that their health conditions** enable them to take part in the 7th Charity Run (the statement to be made by the participant is attached as Appendix 2 and the statement to be made by a participant's parent or legal guardian is provided in Appendix 3). The Appendix must be dropped at the office of the event.
2. The Organizer and its partners as well as persons engaged in the organization of the run are not liable to the participants for any accidents, collisions, personal injuries or physical or property damage occurring before, during or after the run and caused by the participants or third parties. The participants are subject to civil and legal liability for any damages made.
3. The participants are obligated to adhere to the safety measures and are fully liable for their conduct.
4. The Organizer will provide medical services only to runners along the route from the start time to the finish time (set at a specific hour). The Organizer will not cover any medical costs or transport costs that are not covered by the run insurance policy.
5. The participants acknowledge that the run is associated with physical fatigue, risk of accidents, potential bodily injuries or harm (including death), property damage or financial losses.
6. The participants undertake to comply with these Terms and Conditions. By signing the registration form, the participants will acknowledge that they have read these Terms and Conditions and accepted them.
7. A failure to read these Terms & Conditions does not mean that a participant does not have to adhere to them.
8. The participants are obligated to follow any instructions from the police or municipal police officers and the Organizer's emergency services and stewards responsible for the Run's safety on and around the route.

10. The Organizer is not liable for cancellation of the event for unforeseeable reasons beyond their control.
11. Any matters not regulated by these Terms and Conditions will be resolved by the Organizer.
12. Only people with a registration number are allowed on the running route.

## VIII. PERSONAL DATA PROTECTION

1. The controller of your personal data is Fundacja Santander Bank Polska S.A. im. Ignacego Jana Paderewskiego with its registered office in Warsaw.
2. Your personal data will be processed in accordance with the Personal Data Processing Information in relation to the 7th SANTANDER POMAGA CHARITY RUN (provided in Appendix 1 to these Terms and Conditions). By organizing the 7th SANTANDER POMAGA CHARITY RUN we understand the following:

(1) acceptance and verification of entries; (2) registration for the Run; (3) internal administrative purposes of the Foundation and the Bank, claims resolution and defence; (4) other.

3. You have the right to: (1) demand to have access to your personal data; (2) demand that your personal data be rectified; (3) demand to restrict the processing of your personal data; (4) demand to have your personal data erased; (5) demand to have your personal data transferred; (6) object against the processing of your personal data; (7) file a complaint with a supervisory authority.
